Pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosures Requirements) Regulation, 2015 read with SEBI Circular No. CIR/CFD/CMD1/114/2019 dated October 18, 2019, we wish to inform that M/s. Walker Chandiok & Co. LLP, Chartered Accountants (Firm Registration number: 001076N/N500013) have tendered their resignation vide their letter dated 12th November 2021 informing their inability to continue as the Statutory Auditors of the Company and the sole reason for their resignation as mentioned in their resignation letter is "Considering the requirements of the RBI Notification No. DoS.CO.ARG/SEC.01/08.91.001/2021-22 dated 27 April 2021 read with Frequently Asked Questions dated 11 June 2021, ineligible to continue to be the statutory auditors, as having already completed three years as statutory auditors of the Company.".

LLP, Chartered Accountants (Firm Registration number: 001076N/N500013), as Statutory Auditors of the Company. The Audit Committee noted that statutory auditors have not raised any concern or issue, other than above mentioned reason in their resignation letter dated 12th November 2021.

The Board of Directors at its meeting held on 12th November 2021 also noted that there is no other reason other than above mentioned reason in the resignation letter received from the Auditors dated 12th November 2021 and has accepted the resignation.

The copy of the resignation letter dated 12th November, 2021 with Annexure as received from M/s. Walker Chandiok & Co. LLP is attached herewith.
